RE: Public Hearing on the Town's Fiscal Year 2026-2027 (FY27) Millage Rate and Annual Budget

Background Information:

The town has held numerous budget workshops, and the town manager has brought budget information and presentations during regular town Commission meetings over the past few months in order to get a sense of priorities setting for the Commission and Town.

At the last budget workshop, the town manager was asked to bring a budget with the Rollback rate; however, a few Commissioners were also interested in seeing a budget at the 4.6000 Mil flat rate as well.

In the packet are two versions of the budget – one at the Rollback rate of 4.3987 (pages 4-81) and the other at the 4.6000 flat rate (pages 82-159). In each version there are the following components:

- Budget message
- Budget document with flow charts for fire and police
- Capital Improvement Projects document
- Resolution for approval of a millage rate
- Resolution for approval of the budget

Recommendation:

This is the first of two budget hearings in which the Commission must vote first on a millage rate and then a corresponding budget. The budget at the 4.3987 Rollback rate needs three votes to pass. The budget at the 4.6000 flat rate needs at least 4 votes to pass.

At the Rollback rate, basic operations can be funded but no capital project construction that has not already been budgeted. Further, at Rollback rate, the Town will start with much less funding for a 3-vote approval next year, which can compound over time. With either budget, the General Obligation bond is crucial for the Town to keep up with its stormwater and road capital projects.

FISCAL YEAR 2027 BUDGET MESSAGE

To the Honorable Mayor, Vice Mayor, Town Commissioners, and Residents of the Town of Melbourne Beach:

On behalf of Town staff, I am pleased to submit for your review and consideration the Town of Melbourne Beach's proposed Fiscal Year 2027 Budget, covering the period from October 1, 2026, through September 30, 2027, together with a Five-Year Capital Plan, as required by the Town Charter.

The Town of Melbourne Beach remains a financially sound, small barrier-island community whose breathtaking coastal appeal and rich heritage — dating back to 1883 — make it a community of choice for residents and visitors alike. As we work to preserve the Town's hometown charm and the quality of life it embodies, we must continue investing in infrastructure while balancing financial prudence with initiatives that are meaningful to our residents. This budget reflects that continued commitment to fiscal responsibility, transparency, and the preservation of the quality of life our residents value. Through careful evaluation and prioritization of programs and services, the Town maintains essential services — Police, Fire, Public Works, and Code Enforcement — while eliminating unnecessary costs and directing resources toward the initiatives that matter most to our community.

The proposed FY2027 Budget includes the following:

- **Millage rate at the rollback rate of 4.3987 mils:** less than the millage rate last year
 - *A rate that is 4.58% less than last year's rate of 4.6000 mils*
 - *The lowest millage rate on the barrier island and the third lowest in Brevard County*
- **General Fund operating budget of \$5,070,425:** a decrease from the FY2026 adopted budget
 - *No funds have been budgeted from reserves this fiscal year, preserving reserves and providing greater financial security for the Town*

- **Annual stormwater assessment increased to \$68.90 per Equivalent Residential Unit (ERU):** up from \$36.00, to fund the rising cost of basic maintenance of the Town’s stormwater system
 - *This non-ad-valorem assessment has not kept pace with inflation, having gone unchanged for more than 20 years*
 - *The increase will generate an additional \$53,408.02 per year, funding stormwater maintenance, and future risk-reduction projects*
- **Current reserve funds of \$3,067,491:**
 - *Protecting the Town’s financial reserves remains a top priority for the Commission and community, providing financial security amid hurricanes, emergency infrastructure repairs, unforeseen operational needs, and economic uncertainty*
 - *Reserves exceed the 15%–30% range recommended for municipalities by the Government Finance Officers Association and bond rating agencies*
 - *This year, the Finance Department also negotiated an 80-basis-point increase in the interest rate the Town earns on its savings account*

Sound and deliberate financial planning has provided flexibility to maintain core services and invest in capital infrastructure, while limiting obligations on residents and businesses alike.

Bringing Our Community Together

The Town met a number of challenges this year, and in doing so, Commissioners and staff forged new and closer partnerships with neighboring jurisdictions and organizations, including the Hubbs-SeaWorld Research Institute, the Florida Fish and Wildlife Conservation Commission, the Space Coast Transportation Planning Organization, the Rotary Club of Melbourne Beach, the Melbourne Beach Volunteer Firefighters Association, the Florida Joint Legislative Auditing Committee, the National Weather Service, the Brevard County Emergency Management Department, the Town’s volunteer boards, and many more. From rescuing a manatee trapped beneath a town road, to preparing the Town to weather any storm, to welcoming hundreds of athletes for a spectacular triathlon, the Town brought its community together in many ways this year, including:

- **Saving a juvenile manatee, affectionately named “Melby,” who was trapped seven feet underground in a stormwater pipe:** In partnership with the Florida Fish and Wildlife Conservation Commission, the U.S. Fish and Wildlife Service, SeaWorld, Brevard County Public Works and Fire, neighboring municipalities, and the Town’s own fire and police departments the roadway was excavated and a heavy-duty tow truck was used to free Melby. He was loaded onto a specialized transport truck – with hundreds of well-wishers looking on - bound for SeaWorld where he recovered. Melby was successfully rehabilitated and released back into the Indian River Lagoon two months later with a large crowd of supporters and all the staff from the Town, who had been following Melby’s journey to recovery – the Melbourne Beach police department even minted a special Melby the manatee challenge coin. The rescue drew international

attention and highlighted how the Town's partners and friends can come together for a shared cause.

- **Receiving StormReady certification from the National Weather Service:** In partnership with the National Weather Service and the Brevard County Emergency Operations Center, the Town completed training, conducted drills, and hosted a StormReady workshop — complete with ice cream — to better prepare residents to save lives during severe weather events through planning, education, and awareness.
- **Making our streets safer for multi-modal transportation:** Town streets are heavily used by walkers, bikers, e-bikers, scooters, golf carts, and vehicles, particularly during morning and afternoon school hours. In collaboration with the Space Coast Transportation Planning Organization, a study is underway to analyze vehicle speed trends, crash history, enforcement activity, and school travel patterns near Gemini Elementary School, alongside existing roadway conditions, to identify low-cost, high-impact safety improvements on the streets most used by students. The study will also provide targeted speed management and enforcement recommendations that support the Town's safety goals, Vision Zero, and the Safe System Approach, while helping prioritize future transportation investments.
- **Celebrating the 250th anniversary of our nation's founding:** Melbourne Beach's patriotism was on full display this year, as the Public Works team refreshed signage, hung 250th Anniversary banners, planted red-white-and-blue flowers throughout town, painted cabanas and flower containers at our parks, added patriotic lighting to the pier, and painted red-white-and-blue circles on the lawn. A new golf cart parade and patriotic pet competition concluded at Ryckman Park, where the Melbourne Beach Volunteer Firefighters Association served refreshments ahead of the evening's fireworks display, with the Flutie Brothers Band providing the evening's soundtrack. The Parks Board also held an art contest for the nation's 250th anniversary; the winning student artist's mural is now mounted at the front of the Town Community Center.
- **Celebrating the 40th anniversary of the Pineapple Man Triathlon:** In coordination with the Rotary Club of Melbourne Beach and Town staff, the 40th Indian River Network Pineapple Man Triathlon brought more than 700 athletes and their supporters to town to cheer on contestants as they swam, biked, and ran through Melbourne Beach. The Melbourne Beach Fire Department stood ready to assist contestants in the Indian River Lagoon, while the Police Department kept contestants safe from traffic and other distractions along the route. The Pineapple Man Triathlon is Florida's oldest USA Triathlon (USAT)-sanctioned event.

Fortifying Town Services for the Community

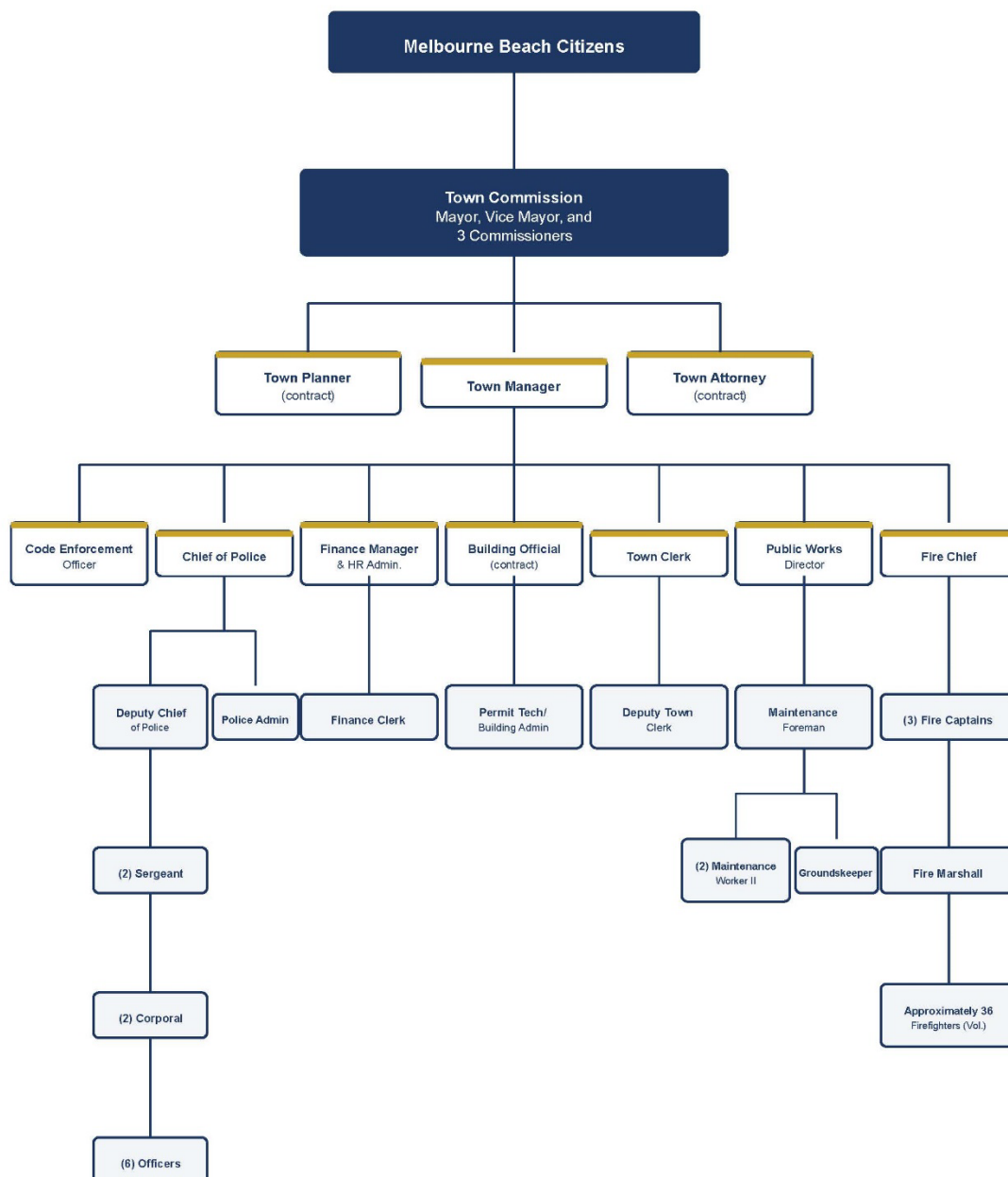
Fiscal Year 2026 brought several notable changes to Town staff and operations that will enhance and expand the services available to Melbourne Beach residents and the surrounding community. The theme of partnership carried through the year, with substantial help and support from the

Melbourne Beach Volunteer Firefighters Association and the Florida Joint Legislative Auditing Committee auditors.

- **New services with new employees:** As positions turned over, the Town hired several new employees, including a new Town Clerk, Code Enforcement Officer, Finance Department Clerk, Building Department Administrative Assistant, Town Manager, and three new Firefighter Captains. With the addition of the new Captains, the Fire Department is now able to offer 24/7 coverage for fire and water rescue calls and provide basic life support services.

- **Improvements to Town Hall:** The Town Hall building received much-needed repairs and improvements this year to accommodate firefighters on shift. The second-floor showers were repaired and leaks mitigated, roof repairs are underway, and — with the generous support and donations of the Melbourne Beach Volunteer Firefighters Association — the second floor was transformed into living quarters for the firefighter captains and volunteers serving 24/7 shifts.
- **Improving processes and procedures:** The Town passed its annual audit and is also being audited this year by the Florida Joint Legislative Auditing Committee (JLAC). Town staff have generously given their time and expertise to provide JLAC auditors with the information needed, and the Town expects results in late December 2026 or January 2027 so it can improve any outdated processes or procedures.

Improving Infrastructure and Planning for the Future

Located on a barrier island with the Atlantic Ocean to the east and the Indian River Lagoon to the west, Melbourne Beach is one of the few places in the United States where residents can watch the sun rise and set over the water. Alongside its wildlife and scenic views, the Town faces a constant challenge in keeping water from encroaching on property and waste materials out of the surrounding waters. Stormwater maintenance and repair remain an ongoing concern, particularly as aging infrastructure — both above and below ground — requires attention.

That is why the Commission opted this year to bring a \$5 million general obligation bond referendum for stormwater and roadway improvements before voters this November. The bond would allow the Town to update its stormwater master plan and undertake several large projects that would otherwise wait years for funding or draw down Town reserves. It would replace a previous infrastructure bond that remained on taxpayers' bills until the Town paid it off this summer. With current funding, the Town completed a number of projects this year, including:

- **Repairs to Basin 1 stormwater system:** Basin 1, one of the Town's largest stormwater basins, had insufficient capacity to handle stormwater as new impervious surface area and larger homes replaced older, smaller residences. Stormwater pipes were replaced in identified areas to mitigate key issues and paving and restoration of residents' lawns was completed as pipes were replaced.
- **Engineering study of Basin 10:** The Commission selected Haley Ward to conduct a comprehensive study of Basin 10 to identify recommendations for mitigating flooding concerns in that basin. Melby the Manatee was discovered during this study!
- **449 Riverside stormwater pipe repairs:** This stormwater pipe southwest of town is bent and is being repaired; the Commission has approved the work, which will begin this fall.

- **6th Street seawall repair:** The seawall on the lagoon side of 6th Street, near its intersection with Pine Street, will undergo repairs this fall. The Commission has approved a contractor and funding source to prevent the seawall from collapsing into the lagoon.
- **Ryckman Park fencing project:** The Commission approved a fencing project along the section of Ryckman Park facing the parking lot to prevent children from running into the street. The project, managed by the Town’s Public Works Department, is underway.

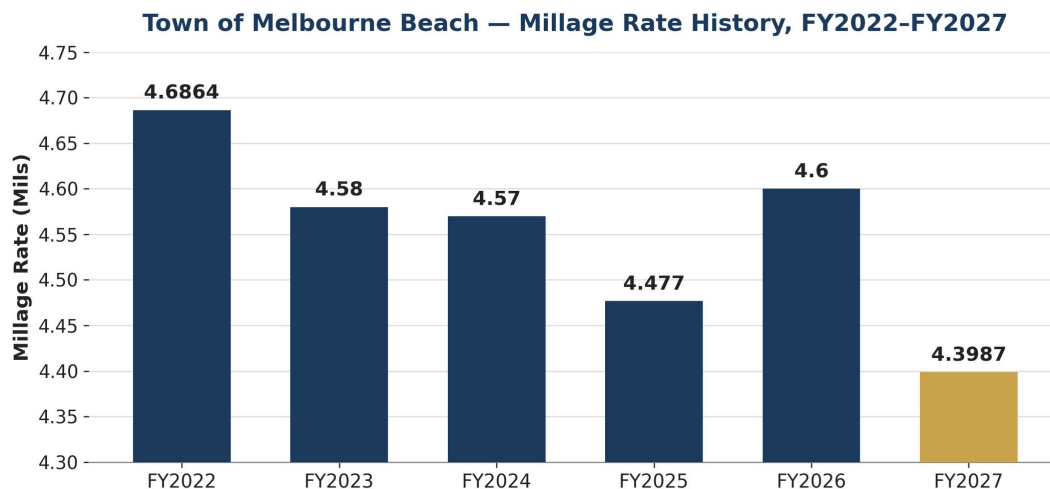
Financial Highlights

Taxable Value

The Town’s current-year net new taxable value — added through new construction, additions, and rehabilitative improvements, as reported by the Brevard County Property Appraiser’s Office — is \$5,441,929. Most of this increase continues to come from new home sales; each time a home sells, the new owner’s taxes are based on the property’s current assessed value. Once a homeowner homesteads their property, the Florida Constitution’s Save Our Homes (SOH) cap limits annual increases in assessed value to 3% or the change in the Consumer Price Index, whichever is lower. Taxable value will continue to rise as homes are bought and sold, so long as market values increase.

Millage Rate

The FY2027 millage rate is at the rollback rate of 4.3987 mils. The chart below shows the five-year millage rate history.



Tax Rate Impact on Residents

As a result of the Town’s commitment to long-term financial stability, the Town is able to maintain Police, Fire, Public Works, and Code Enforcement services at the rollback rate of 4.3987 mils. *The*

Town of Melbourne Beach continues to carry the lowest millage rate on the barrier island and the third lowest in Brevard County.

At this millage rate, no additional capital projects can move forward, including stormwater and street paving, unless the general obligation bond is approved by voters in November.

- **Potential property tax reform:** The Florida Legislature placed a State constitutional amendment on the November ballot that would increase homestead exemptions from \$50,000 to \$250,000 over the next two years. It would also limit what those taxes can fund, curb non-homestead property valuations and have the Florida Legislature work to eliminate non-school homestead property taxes altogether. Should the amendment be approved by voters, the Town will lose a substantial portion of its income and will need to identify new, higher fees and/or reductions in service levels next year.

Budget Overview

The proposed General Fund budget totaling \$5,070,425 is a decrease from the Fiscal Year 2026 adopted budget. Under governmental accounting standards, all revenue must be offset by an equal amount of expense; bringing additional revenue into the General Fund from other Town funds increases total expense by the same amount, which in turn increases the overall budget total.

In addition to being reflected in the general fund this year, parking revenue from Ryckman Park (Fund 175) and Ocean Park (Fund 172) support the Town's free community events, festivals, and movies, as well as upkeep of the playground, basketball, and tennis courts. Expenses

The traditional “below the line” budget section within each department reflects the direct costs of day-to-day Town operations. Costs “above the line” refer to salaries and benefits. Departmental costs are calculated using historical data, upcoming project needs, and notices of rate changes from vendors, the State of Florida, and utility providers.

Salaries and Benefits — “Above the Line”

- Employees in good standing are entitled to a 4.25% wage increase.
- Police officers will receive a \$3,000 increase in base salary.
- The Town pays 100% of employee health insurance premiums and 50% of the premium for a spouse and children.
- The Town contributes the state-mandated 13.59% (37.74% for firefighters) to the Florida Retirement System; employees contribute 3%.
- The Town will contribute \$225,481 to the Police Pension Fund for FY2027 (of which the state contributes \$53,000 recognized as revenue to the town); police officers contribute 5% of annual pay.
- The Town provides \$30,000 in life insurance for police officers and firefighters, and \$15,000 for all other employees.

Operating Expenses — “Below the Line”

Below-the-line operating expenses increased across all departments in FY2027, driven primarily by rising health insurance costs and the increased cost of goods and services town-wide. The Finance Department, however, took a close look at costs and identified several efficiencies that will benefit the Town and its budget process this year, including:

- After significant negotiations, insurance costs for Fiscal Year 2027 will be reduced by approximately \$100,000 — a rate reduction the Town has not received in nearly ten years.
- The Town's banking services vendor has agreed to raise the interest rate on the Town's banking account by 80 basis points, with negotiations underway to reduce or eliminate certain service charges.
- All gas purchases for Town vehicles will be reduced by \$0.15 per gallon. New billing efficiencies mean the vendor now sends a single invoice instead of reconciling individual credit card purchases.

Special Revenue, Agency & Historic Preservation Funds

The Town maintains several special revenue and agency funds that account for restricted revenue sources such as parking, stormwater assessments, donations, and dedicated board activities. Except where noted, these funds are self-supporting, and revenues remain within each fund, with balances rolling forward each fiscal year. The table below summarizes FY2027 budgeted activity for each fund.

Note: Ocean Park (Fund 172) and Ryckman Park (Fund 175) are the Town's two parking-revenue funds; parking revenue is not reflected in the General Fund and instead funds free community events, festivals, and recreational facility upkeep in each respective park.

Capital and Debt Service Funds

The proposed budget has been developed through workshops and public meetings. Each year, the Town Manager and staff review departmental goals and objectives for the next five years to establish a baseline for capital expenditures; the Town Commission then reviews and incorporates these into the Five-Year Capital Plan. Planning high-dollar capital projects on a five-year schedule allows for better level-loading during a longer cash-accumulation period, which is necessary given the size of capital project costs relative to the Town's limited annual revenue.

Capital expenditures are budgeted within each department's operating expense; once purchased, the Town tracks capital purchases as depreciable assets over a useful life of five to thirty years.

This section describes the Town's capital program and outstanding debt obligations. The Municipal Complex Bond (Fund 201) is serviced through an annual transfer from the General Fund. The Stormwater Bond (Fund 202) was paid in full in FY2026.

The Long-Term Capital Projects Fund (333) and Stormwater Capital Projects Fund (341) receive departmental transfers to fund equipment, vehicle, and infrastructure replacement on a five-year rolling schedule.

FY2027 Capital Highlights

- Public Safety: \$124,780 in short- and long-term capital — police vehicle and equipment (\$22,820), fire bunker gear, and engine payment (\$101,960).
- Fund 175 (Ryckman Park): \$25,000 allocated in long-term capital for playground equipment replacement and \$30,000 in short-term capital for bathroom roof repairs.
- General Government: \$49,511 for Town Hall elevator, with A/C unit and computer replacement, part of a \$64,511 total General Services capital outlay.

Debt Service

The Town carries two outstanding debt obligations: a municipal refunding bond issued through the Florida Municipal Loan Council (FMLC) that financed the Municipal Complex, and a lease-purchase agreement that financed the Fire Department's new engine (Engine 58). Both obligations are fixed-rate, fully amortizing, and serviced through annual transfers from the General Fund — the bond through Fund 201 (Municipal Complex Bond Debt Service Fund) and the fire engine lease through the Fire Control Department's (Dept. 22) annual capital outlay. Together, these two obligations represent the entirety of the Town's outstanding long-term debt.

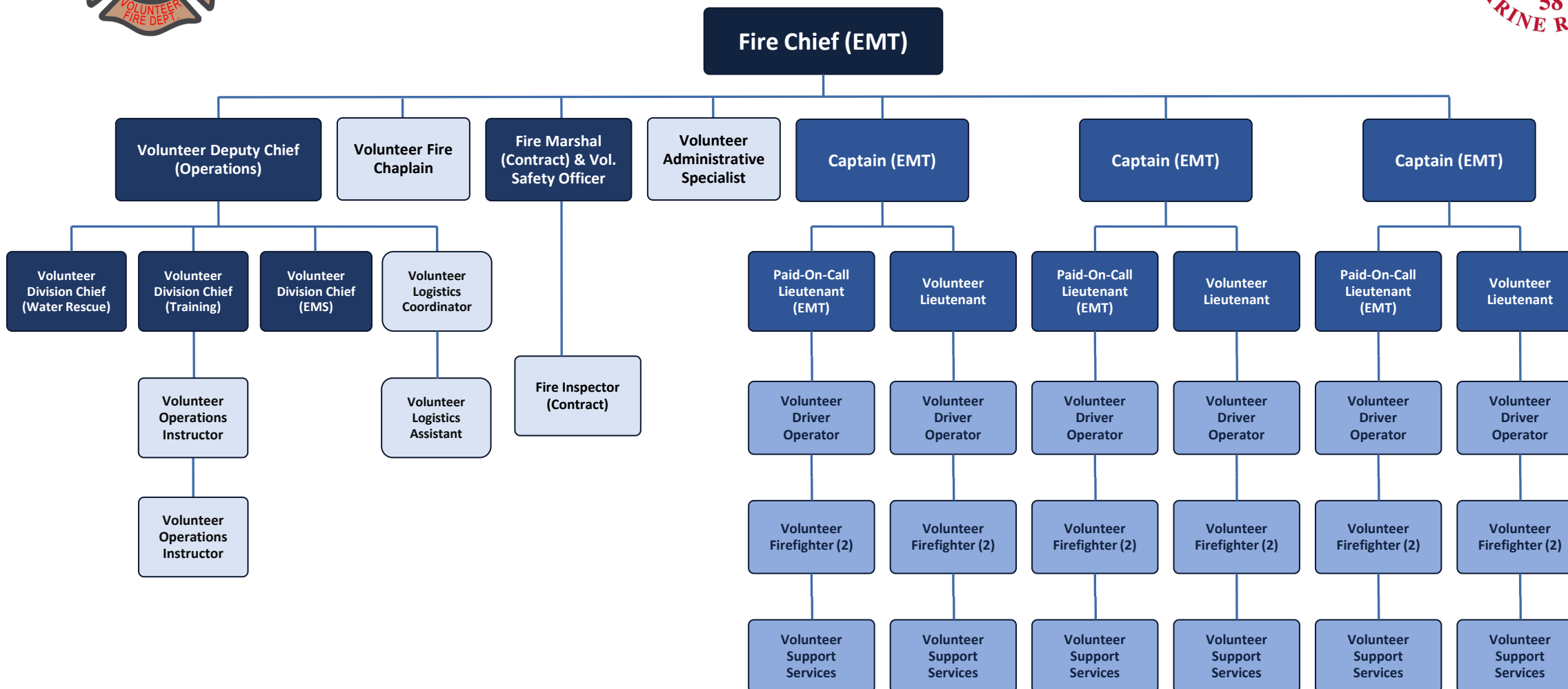


Melbourne Beach Volunteer Fire Department

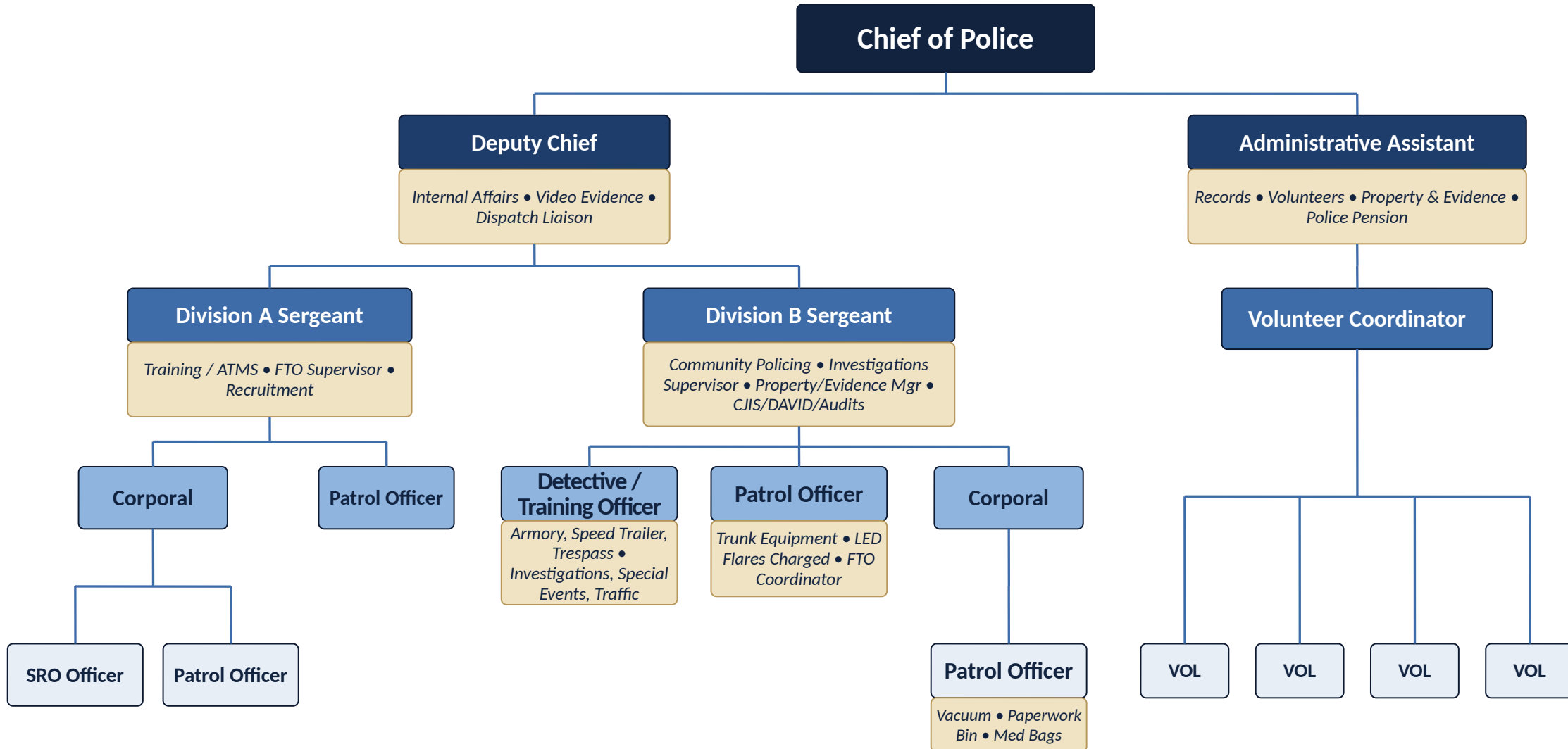

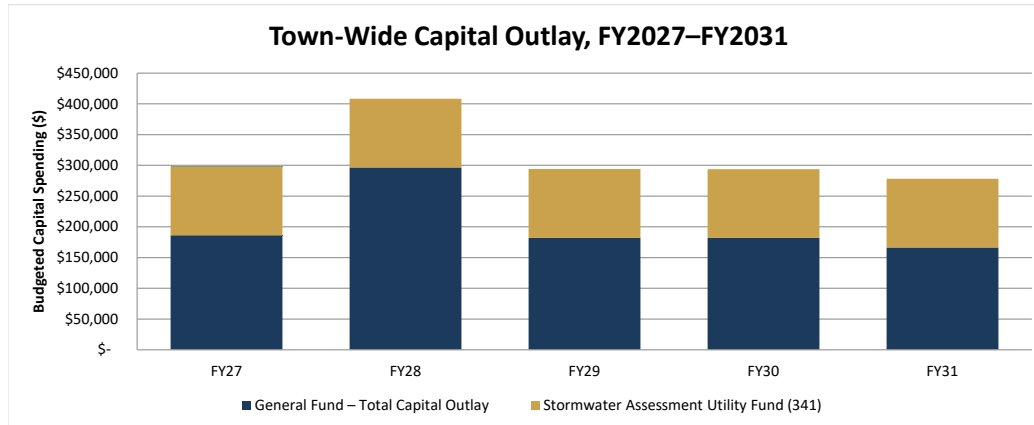

FISCAL YEAR 2027 BUDGET MESSAGE

To the Honorable Mayor, Vice Mayor, Town Commissioners, and Residents of the Town of Melbourne Beach:

On behalf of Town staff, I am pleased to submit for your review and consideration the Town of Melbourne Beach's proposed Fiscal Year 2027 Budget, covering the period from October 1, 2026, through September 30, 2027, together with a Five-Year Capital Plan, as required by the Town Charter.

The Town of Melbourne Beach remains a financially sound, small barrier-island community whose breathtaking coastal appeal and rich heritage — dating back to 1883 — make it a community of choice for residents and visitors alike. As we work to preserve the Town's hometown charm and the quality of life it embodies, we must continue investing in infrastructure while balancing financial prudence with initiatives that are meaningful to our residents. This budget reflects that continued commitment to fiscal responsibility, transparency, and the preservation of the quality of life our residents value. Through careful evaluation and prioritization of programs and services, the Town maintains essential services — police, fire, public works, and code enforcement — while eliminating unnecessary costs and directing resources toward the initiatives that matter most to our community.

The proposed FY2027 Budget includes the following:

- **Millage rate held flat at 4.6000 mils:** unchanged from FY2026
 - *A rate that is 4.58% above the rollback rate of 4.3987 mils*
 - *The lowest millage rate on the barrier island and the fourth lowest in Brevard County*
- **General Fund operating budget of \$5,126,817:** a decrease from the FY2026 adopted budget
 - *No funds have been budgeted from reserves this fiscal year, preserving reserves and providing greater financial security for the Town*

- **Annual stormwater assessment increased to \$68.90 per Equivalent Residential Unit (ERU):** up from \$36.00, to fund the rising cost of basic maintenance of the Town’s stormwater system
 - *This non-ad-valorem assessment has not kept pace with inflation, having gone unchanged for more than 20 years*
 - *The increase will generate an additional \$53,408.02 per year, funding stormwater maintenance, and future risk-reduction projects*
- **Current reserve funds of \$3,067,491:**
 - *Protecting the Town’s financial reserves remains a top priority for the Commission and community, providing financial security amid hurricanes, emergency infrastructure repairs, unforeseen operational needs, and economic uncertainty*
 - *Reserves exceed the 15%–30% range recommended for municipalities by the Government Finance Officers Association and bond rating agencies*
 - *This year, the Finance Department also negotiated an 80-basis-point increase in the interest rate the Town earns on its savings account*

Sound and deliberate financial planning has provided flexibility to maintain core services and invest in capital infrastructure, while limiting obligations on residents and businesses alike.

Bringing Our Community Together

The Town met a number of challenges this year, and in doing so, Commissioners and staff forged new and closer partnerships with neighboring jurisdictions and organizations, including the Hubbs-SeaWorld Research Institute, the Florida Fish and Wildlife Conservation Commission, the Space Coast Transportation Planning Organization, the Rotary Club of Melbourne Beach, the Melbourne Beach Volunteer Firefighters Association, the Florida Joint Legislative Auditing Committee, the National Weather Service, the Brevard County Emergency Management Department, the Town’s volunteer boards, and many more. From rescuing a manatee trapped beneath a town road, to preparing the Town to weather any storm, to welcoming hundreds of athletes for a spectacular triathlon, the Town brought its community together in many ways this year, including:

- **Saving a juvenile manatee, affectionately named “Melby,” who was trapped seven feet underground in a stormwater pipe:** In partnership with the Florida Fish and Wildlife Conservation Commission, the U.S. Fish and Wildlife Service, SeaWorld, Brevard County Public Works and Fire, neighboring municipalities, and the Town’s own fire and police departments, the roadway was excavated and a heavy-duty tow truck was used to free Melby. He was loaded onto a specialized transport truck – with hundreds of well-wishers looking on - bound for SeaWorld where he recovered. Melby was successfully rehabilitated and released back into the Indian River Lagoon two months later with a large crowd of supporters and all the staff from the Town, who had been following Melby’s journey to recovery – the Melbourne Beach police department even minted a special Melby the manatee challenge coin. The rescue drew international attention and highlighted how the Town’s partners and friends can come together for a

shared cause.

- **Receiving StormReady certification from the National Weather Service:** In partnership with the National Weather Service and the Brevard County Emergency Operations Center, the Town completed training, conducted drills, and hosted a StormReady workshop — complete with ice cream — to better prepare residents to save lives during severe weather events through planning, education, and awareness.
- **Making our streets safer for multi-modal transportation:** Town streets are heavily used by walkers, bikers, e-bikers, scooters, golf carts, and vehicles, particularly during morning and afternoon school hours. In collaboration with the Space Coast Transportation Planning Organization, a study is underway to analyze vehicle speed trends, crash history, enforcement activity, and school travel patterns near Gemini Elementary School, alongside existing roadway conditions, to identify low-cost, high-impact safety improvements on the streets most used by students. The study will also provide targeted speed management and enforcement recommendations that support the Town’s safety goals, Vision Zero, and the Safe System Approach, while helping prioritize future transportation investments.
- **Celebrating the 250th anniversary of our nation’s founding:** Melbourne Beach’s patriotism was on full display this year, as the Public Works team refreshed signage, hung 250th Anniversary banners, planted red-white-and-blue flowers throughout town, painted cabanas and flower containers at our parks, added patriotic lighting to the pier, and painted red-white-and-blue circles on the lawn. A new golf cart parade and patriotic pet competition concluded at Ryckman Park, where the Melbourne Beach Volunteer Firefighters Association served refreshments ahead of the evening’s fireworks display, with the Flutie Brothers Band providing the evening’s soundtrack. The Parks Board also held an art contest for the nation’s 250th anniversary; the winning student artist’s mural is now mounted at the front of the Town Community Center.
- **Celebrating the 40th anniversary of the Pineapple Man Triathlon:** In coordination with the Rotary Club of Melbourne Beach and Town staff, the 40th Indian River Network Pineapple Man Triathlon brought more than 700 athletes and their supporters to town to cheer on contestants as they swam, biked, and ran through Melbourne Beach. The Melbourne Beach Fire Department stood ready to assist contestants in the Indian River Lagoon, while the Police Department kept contestants safe from traffic and other distractions along the route. The Pineapple Man Triathlon is Florida’s oldest USA Triathlon (USAT)-sanctioned event.

Fortifying Town Services for the Community

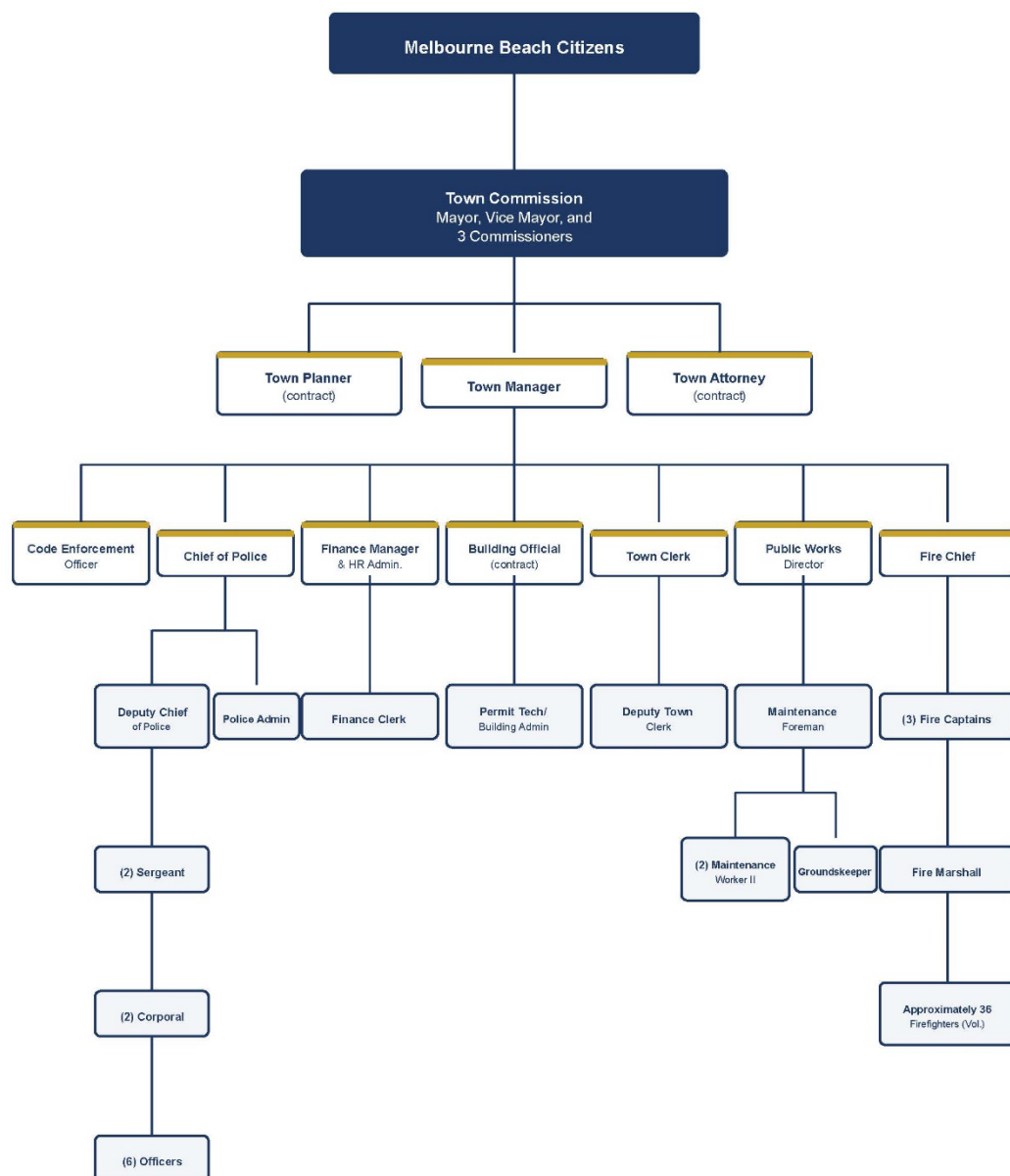
Fiscal Year 2026 brought several notable changes to Town staff and operations that will enhance and expand the services available to Melbourne Beach residents and the surrounding community. The theme of partnership carried through the year, with substantial help and support from the

Melbourne Beach Volunteer Firefighters Association and the Florida Joint Legislative Auditing Committee auditors.

- **New services with new employees:** As positions turned over, the Town hired several new employees, including a new Town Clerk, Code Enforcement Officer, Finance Department Clerk, Building Department Administrative Assistant, Town Manager, and three new Firefighter Captains. With the addition of the new Captains, the Fire Department is now able to offer 24/7 coverage for fire and water rescue calls and provide basic life support services (see Melbourne Beach Town Organization Chart).

- **Improvements to Town Hall:** The Town Hall building received much-needed repairs and improvements this year to accommodate firefighters on shift. The second-floor showers were repaired and leaks mitigated, roof repairs are underway, and — with the generous support and donations of the Melbourne Beach Volunteer Firefighters Association — the second floor was transformed into living quarters for the firefighter captains and volunteers serving 24/7 shifts.
- **Improving processes and procedures:** The Town passed its annual audit and is also being audited this year by the Florida Joint Legislative Auditing Committee (JLAC). Town staff have generously given their time and expertise to provide JLAC auditors with the information needed, and the Town expects results in late December 2026 or January 2027 so it can improve any outdated processes or procedures.

Improving Infrastructure and Planning for the Future

Located on a barrier island with the Atlantic Ocean to the east and the Indian River Lagoon to the west, Melbourne Beach is one of the few places in the United States where residents can watch the sun rise and set over the water. Alongside its wildlife and scenic views, the Town faces a constant challenge in keeping water from encroaching on property and waste materials out of the surrounding waters. Stormwater maintenance and repair remain an ongoing concern, particularly as aging infrastructure — both above and below ground — requires attention.

That is why the Commission opted this year to bring a \$5 million general obligation bond referendum for stormwater and roadway improvements before voters this November. The bond would allow the Town to update its stormwater master plan and undertake several large projects that would otherwise wait years for funding or draw down Town reserves. It would replace a previous infrastructure bond that remained on taxpayers' bills until the Town paid it off this summer. With current funding, the Town completed a number of projects this year, including:

- **Repairs to Basin 1 stormwater system:** Basin 1, one of the Town's largest stormwater basins, had insufficient capacity to handle stormwater as new impervious surface area and larger homes replaced older, smaller residences. Stormwater pipes were replaced in identified areas to mitigate key issues and paving and restoration of residents' lawns was completed as pipes were replaced.
- **Engineering study of Basin 10:** The Commission selected Haley Ward to conduct a comprehensive study of Basin 10 to identify recommendations for mitigating flooding concerns in that basin. Melby the Manatee was discovered during this study!
- **449 Riverside stormwater pipe repairs:** This stormwater pipe southwest of town is bent and is being repaired; the Commission has approved the work, which will begin this fall.
- **6th Street seawall repair:** The seawall on the lagoon side of 6th Street, near its intersection with Pine Street, will undergo repairs this fall. The Commission has approved a contractor and funding

source to prevent the seawall from collapsing into the lagoon.

- **Ryckman Park fencing project:** The Commission approved a fencing project along the section of Ryckman Park facing the parking lot to prevent children from running into the street. The project, managed by the Town’s Public Works Department, is underway.

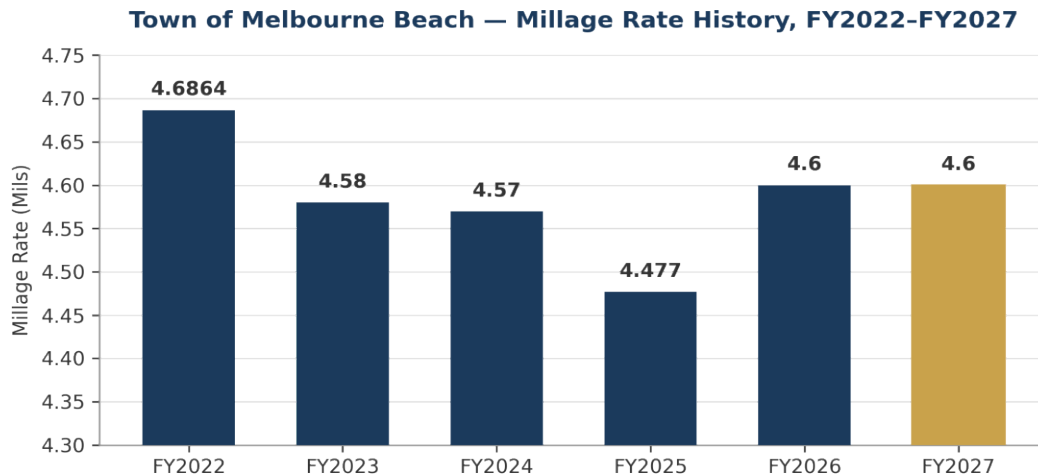
Financial Highlights

Taxable Value

The Town’s current-year net new taxable value — added through new construction, additions, and rehabilitative improvements, as reported by the Brevard County Property Appraiser’s Office — is \$5,441,929. Most of this increase continues to come from new home sales; each time a home sells, the new owner’s taxes are based on the property’s current assessed value. Once a homeowner homesteads their property, the Florida Constitution’s Save Our Homes (SOH) cap limits annual increases in assessed value to 3% or the change in the Consumer Price Index, whichever is lower. Taxable value will continue to rise as homes are bought and sold, so long as market values increase.

Millage Rate

The FY2027 millage rate is 4.6000 mils, unchanged from FY2026. The chart below shows the five-year millage rate history.



Tax Rate Impact on Residents

As a result of the Town’s commitment to long-term financial stability, the Town is able to maintain Police, Fire, Public Works, and Code Enforcement services at a tax rate that is 4.58% above the rollback rate of 4.3987 mils. *The Town of Melbourne Beach continues to carry the lowest millage rate on the barrier island and the fourth lowest in Brevard County.*

- **Potential property tax reform:** The Florida Legislature placed a State constitutional amendment on the November ballot that would increase homestead exemptions from \$50,000 to \$250,000 over the

next two years. It would also limit what those taxes can fund, curb non-homestead property valuations and have the Florida Legislature work to eliminate non-school homestead property taxes altogether. Should the amendment be approved by voters, the Town will lose a substantial portion of its income and will need to identify new, higher fees and/or reductions in service levels next year.

Budget Overview

The proposed General Fund budget totals \$5,126,817, a decrease from the Fiscal Year 2026 adopted budget. Under governmental accounting standards, all revenue must be offset by an equal amount of expense; bringing additional revenue into the General Fund from other Town funds increases total expense by the same amount, which in turn increases the overall budget total.

Parking revenues are not reflected in the General Fund. Ryckman Park (Fund 175) and Ocean Park (Fund 172) are self-supporting special revenue funds, each with its own revenue and expense categories; all revenue generated remains within the respective fund and rolls forward year to year. Ryckman Park anticipates FY2027 revenue of \$99,900 against expenses of \$142,950, funded in part by \$67,046 in carried-forward cash. Ocean Park anticipates FY2027 revenue of \$140,500 against expenses of \$53,452. Parking revenue supports the Town's free community events, festivals, and movies, as well as upkeep of the playground, basketball, and tennis courts. See the Special Revenue Funds section of the budget book for full details.

Expenses

The traditional “below the line” budget section within each department reflects the direct costs of day-to-day Town operations. Costs “above the line” refer to salaries and benefits. Departmental costs are calculated using historical data, upcoming project needs, and notices of rate changes from vendors, the State of Florida, and utility providers.

Salaries and Benefits — “Above the Line”

- Employees in good standing are entitled to a 3.75% wage increase.
- Police officers will receive a \$3,000 increase in base salary.
- The Town pays 100% of employee health insurance premiums and 50% of the premium for a spouse and children.
- The Town contributes the state-mandated 13.59% (37.74% for firefighters) to the Florida Retirement System; employees contribute 3%.
- The Town will contribute \$225,481 to the Police Pension Fund for FY2027 (of which the state contributes \$53,000 recognized as revenue to the town); police officers contribute 5% of annual pay.
- The Town provides \$30,000 in life insurance for police officers and firefighters, and \$15,000 for all other employees.

Operating Expenses — “Below the Line”

Below-the-line operating expenses increased across all departments in FY2027, driven primarily by rising health insurance costs and the increased cost of goods and services town-wide. The Finance Department, however, took a close look at costs and identified several efficiencies that will benefit the Town and its budget process this year, including:

- After significant negotiations, insurance costs for Fiscal Year 2027 will be reduced by approximately \$100,000 — a rate reduction the Town has not received in nearly ten years.
- The Town’s banking services vendor has agreed to raise the interest rate on the Town’s banking account by 80 basis points, with negotiations underway to reduce or eliminate certain service charges.
- All gas purchases for Town vehicles will be reduced by \$0.15 per gallon. New billing efficiencies mean the vendor now sends a single invoice instead of reconciling individual credit card purchases.

Special Revenue, Agency & Historic Preservation Funds

The Town maintains several special revenue and agency funds that account for restricted revenue sources such as parking, stormwater assessments, donations, and dedicated board activities. Except where noted, these funds are self-supporting, and revenues remain within each fund, with balances rolling forward each fiscal year. The table below summarizes FY2027 budgeted activity for each fund.

Note: Ocean Park (Fund 172) and Ryckman Park (Fund 175) are the Town’s two parking-revenue funds; parking revenue is not reflected in the General Fund and instead funds free community events, festivals, and recreational facility upkeep in each respective park.

Capital and Debt Service Funds

The proposed budget has been developed through workshops and public meetings. Each year, the Town Manager and staff review departmental goals and objectives for the next five years to establish a baseline for capital expenditures; the Town Commission then reviews and incorporates these into the Five-Year Capital Plan. Planning high-dollar capital projects on a five-year schedule allows for better level-loading during a longer cash-accumulation period, which is necessary given the size of capital project costs relative to the Town's limited annual revenue.

Capital expenditures are budgeted within each department's operating expense; once purchased, the Town tracks capital purchases as depreciable assets over a useful life of five to thirty years.

This section describes the Town's capital program and outstanding debt obligations. The Municipal Complex Bond (Fund 201) is serviced through an annual transfer from the General Fund. The Stormwater Bond (Fund 202) was paid in full in FY2026.

The Long-Term Capital Projects Fund (333) and Stormwater Capital Projects Fund (341) receive departmental transfers to fund equipment, vehicle, and infrastructure replacement on a five-year rolling schedule.

FY2027 Capital Highlights

- Public Safety: \$117,670 in short- and long-term capital — police vehicle and equipment (\$15,710), fire bunker gear, and engine payment (\$101,960).
- Fund 175 (Ryckman Park): \$25,000 allocated in long-term capital for playground equipment replacement and \$30,000 in short-term capital for bathroom roof repairs.
- General Government: \$100,000 for Town Hall elevator, with A/C unit and computer replacement, part of a \$115,000 total General Services capital outlay.

Debt Service

The Town carries two outstanding debt obligations: a municipal refunding bond issued through the Florida Municipal Loan Council (FMLC) that financed the Municipal Complex, and a lease-purchase agreement that financed the Fire Department's new engine (Engine 58).

Both obligations are fixed-rate, fully amortizing, and serviced through annual transfers from the General Fund — the bond through Fund 201 (Municipal Complex Bond Debt Service Fund) and the fire engine lease through the Fire Control Department's (Dept. 22) annual capital outlay.

Together, these two obligations represent the entirety of the Town's outstanding long-term debt.

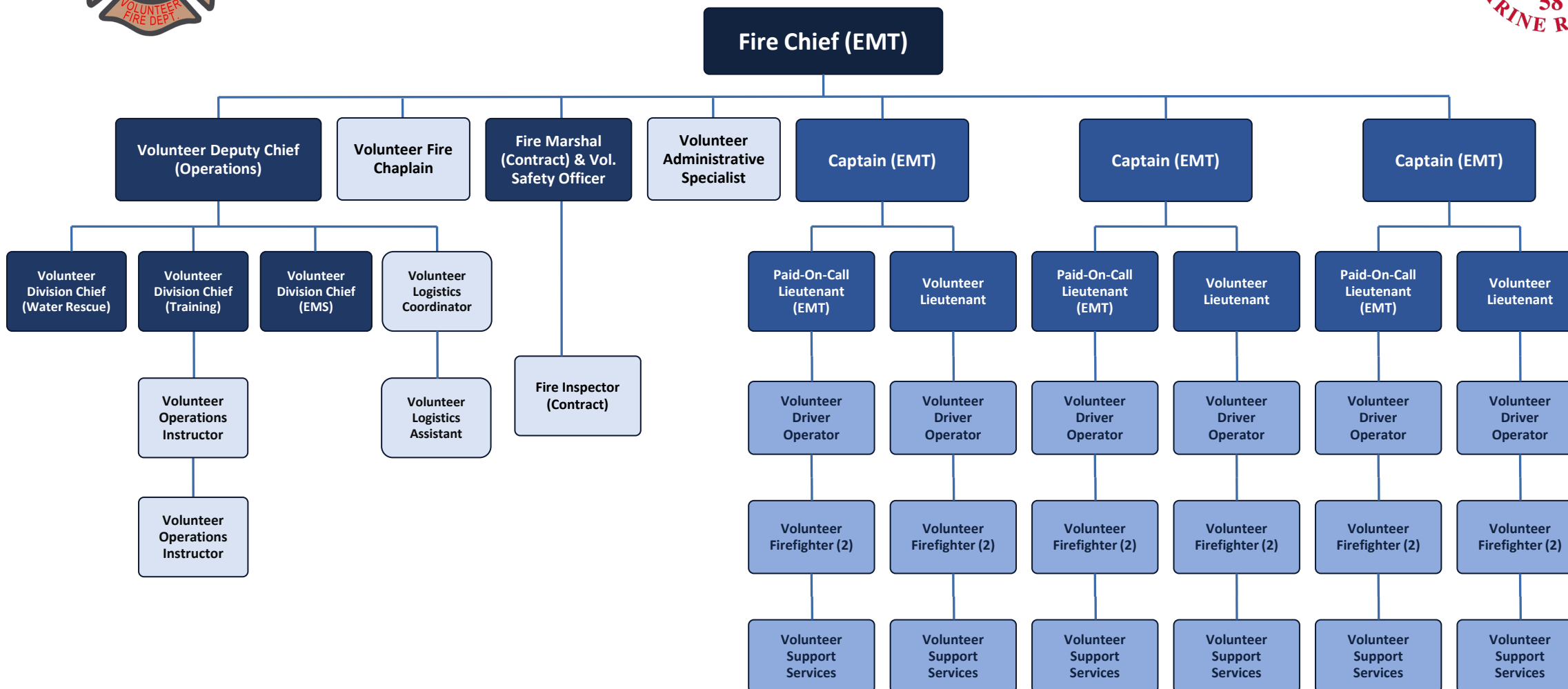


Melbourne Beach Volunteer Fire Department

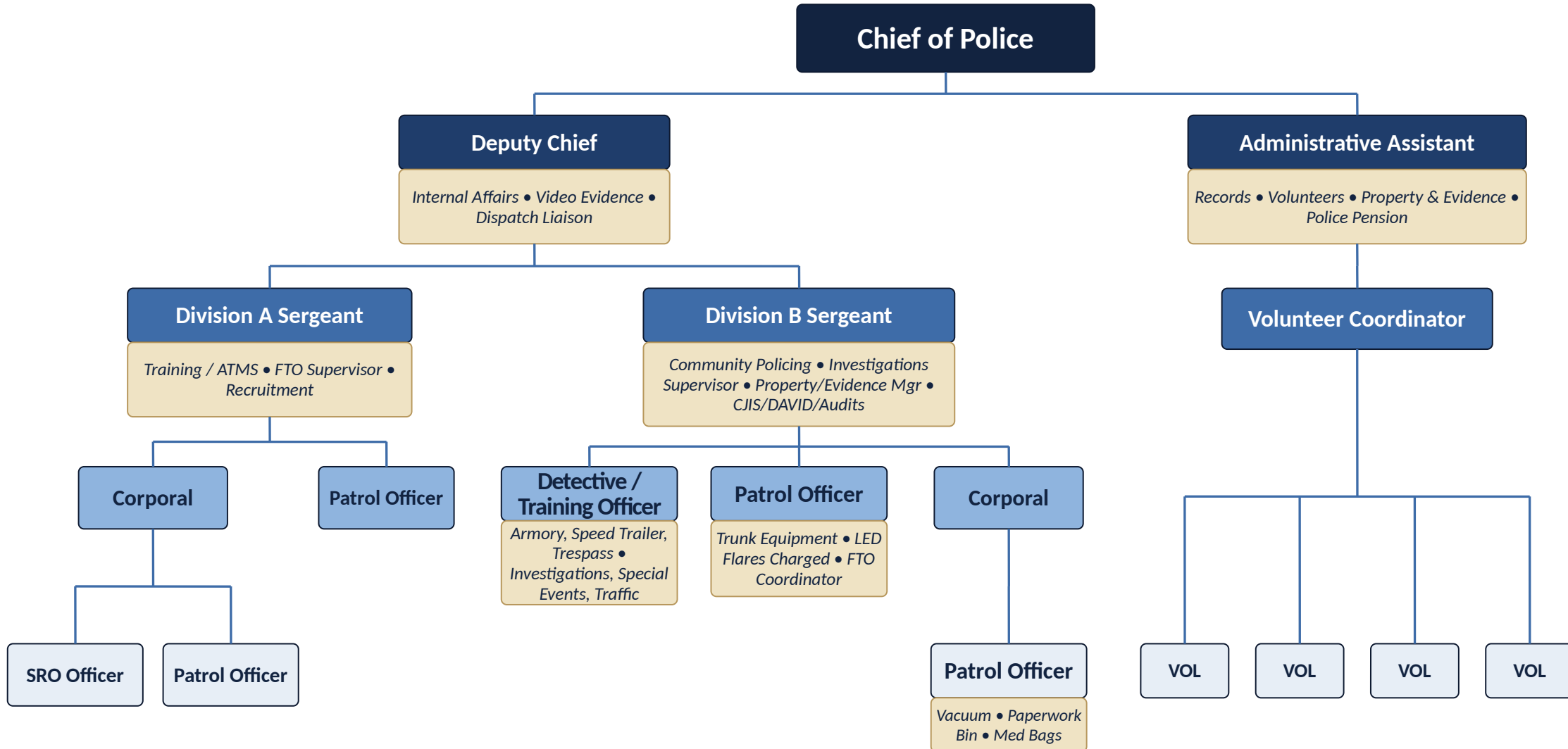

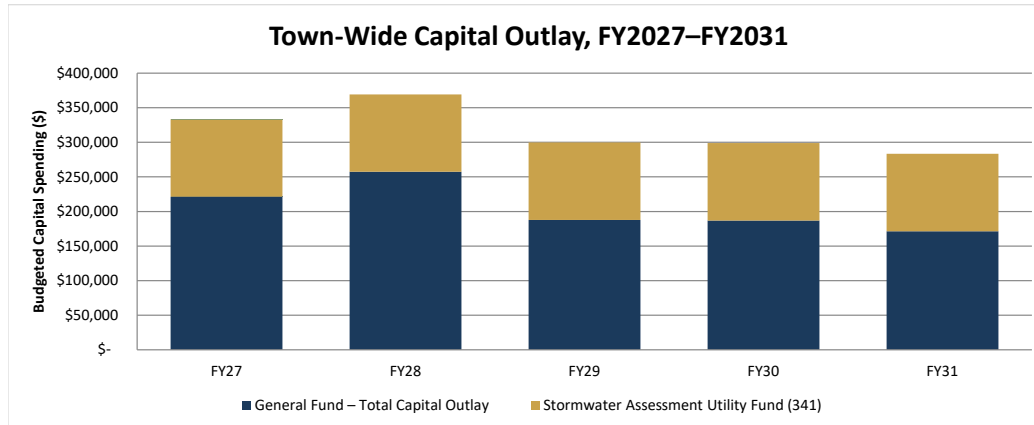
