



### **Brevard County:**

- Visit the Brevard CARES website for details on the <u>Small Business and Nonprofit</u> <u>Organizations grant on-line application</u>.
  - Small businesses and nonprofit organizations may be eligible for grants up to \$10,000 to offset expenses and lost revenue related to impacts from COVID.
  - · Application period remains open
- Applicants for the Rental/Mortgage Assistance Program and Utility/Security Deposit Program, must review and submit all of the required documents and attachments to qualify for assistance as instructed on the <u>Housing and Human Services Coronavirus</u> <u>Assistance Program application form</u>.
- The UF/Brevard Extension Service is hosting a weekly farmer's market where eligible residents can obtain CARES Act dollars for vendor purchases.

  - Fridays at the Welcome Center, 419 South Hopkins Avenue, Titusville, 3-6 PM
  - 1st/3rd Saturdays at Riverview Park in Melbourne from 10 AM 3 PM
  - 2<sup>nd</sup>/4<sup>th</sup> Saturday at 4220 Dixie Highway NE in Palm Bay from 10 AM 2 PM

#### **Community Feeding Operations:**

- For information on food pantry locations and how to access help, utilize the <u>United Way of Brevard's COVID-19 Community Resource guide</u>. It is recommended that you call ahead to verify availability
- Brevard County Public Schools continue to offer meals for all children up to 18 years old at various food distribution sites through December 31.
  - Food distribution sites are open Mondays, Wednesdays, and Fridays.

- The county has partnered with the Children's Hunger Project to distribute 36,065 weekend meals to date
- To date, Brevard County's "Pop up Pantry" feeding operation has distributed 2 million meals

#### West Melbourne

- The masking requirement in essential businesses has been extended to September 28
- All businesses in West Melbourne must post their face mask policy
- Customers of specific essential businesses must wear a mask while inside the essential businesses, with certain exemptions
- Additional West Melbourne businesses, at their discretion, may opt-into the emergency ordinance such that the Police Department is able to enforce the ordinance within their particular business
- Municipal buildings are closed to the public except for the purpose of City Council and City board meetings, and for voting on election days

### **State/National Updates**

- The Florida Department of Health urges Floridians to answer calls from (833) 673-0864 (0865, 0866, 0867, 0868), (833) 443-5364, (850) 583-2419, or county health departments regarding #COVID19 contact tracing.
- The CDC has released Considerations for Outdoor Learning Gardens and Community Gardens. These recommendations are meant for managers of outdoor learning gardens, such as school and community gardens. Garden managers can use the recommendations to help ensure a safe learning environment and access to healthy food, while helping prevent the spread of COVID-19.
- <u>The CDC released recommendations for staying safe during holiday gatherings like Halloween</u> These include: keeping social distance, hosting outdoor activities, and limiting the number of attendees.
