

 - Small businesses and nonprofit organizations may be eligible for grants up to \$10,000 to offset expenses and lost revenue related to impacts from COVID.
 - <u>Small Business PPE Kit Applications reopened October 5, 2020. Distribution</u> began October 12, 2020.
- Applicants for the Rental/Mortgage Assistance Program and Utility/Security Deposit Program, must review and submit all of the required documents and attachments to qualify for assistance as instructed on the <u>Housing and Human Services Coronavirus</u> <u>Assistance Program application form.</u>
- The UF/Brevard Extension Service is hosting a weekly farmer's market where eligible residents can obtain CARES Act dollars for vendor purchases.

 - Fridays at the Welcome Center, 419 South Hopkins Avenue, Titusville, 3-6 PM

 - 2nd/4th Saturday at 4220 Dixie Highway NE in Palm Bay from 10 AM 2 PM

Community Feeding Operations:

- For information on food pantry locations and how to access help, utilize the <u>United Way of Brevard's COVID-19 Community Resource guide</u>. It is recommended that you call ahead to verify availability
- Brevard County Public Schools continue to offer meals for all children up to 18 years old at various food distribution sites through December 31.
 - Food distribution sites are open Mondays, Wednesdays, and Fridays.
 <u>Distribution Locations</u>
- The county has partnered with the Children's Hunger Project to distribute 40,833 weekend meals to date
- Brevard County's "Pop up Pantry" feeding operation has distributed 2.07 million meals to date. From 10/6 10/13, served 2,780 cars and 26 walk-ups for a total 2,993 families

State/National Updates

• The CDC has an new webpage that features new ways of trick or treating and other Halloween activities. These include:

• West Melbourne COVID-19 information

- When trick or treating or participating in other Halloween activities with people outside your household, wear a mask. You can make it fun by making your mask part of your costume, but when it comes to slowing the spread of COVID-19, a costume mask is not a substitute for a cloth mask. Also, do not wear a costume mask over a cloth mask. It can make breathing more difficult.
- If you're heading out to trick-or-treat this year, or planning to put candy out for trick-or treaters, remember to avoid direct contact with trick-or-treaters and give treats away outdoors if possible. Set up a station with individually bagged treats for kids to take, wash hands before handling treats, and wear a mask.
- If you're planning to participate in activities like decorating and carving pumpkins; visiting an orchard, forest or corn maze; attending an outdoor scavenger hunt; or hosting an outdoor costume party, remember to wear a mask, stay at least 6 feet from others who do not live with you, and wash your hands frequently.
- The Centers for Medicare and Medicaid Services (CMS) have issued an update to CMS Memo QSO-20-38-NH to allow nursing homes to use either the state or federal published county positivity rates to determine the frequency of routine staff testing.
