### **Town Commission Special Agenda Item**

Section: Old Business Meeting Date: February 3, 2021 Subject: Lights for Ryckman Park & Town Hall area

**Background Information**: Material failure of the 13 pole lights in Ryckman Park and the areas of the Community Center and Town Hall invoked the need to remove them. This failure is attributed to the lights likely having reached having reached their useful life span. Aging in a salt atmosphere contributed to very high corrosion of the pole bases. This weakened the poles to the point that they could be pushed over by 3 teenagers during horseplay. Our concerns over the condition of the poles and the possibility of them falling over and injuring someone lead us to immediately remove them. Replacement of the poles are the only option. Removal of the pole lights causes great concern on our part for safety and security in the park at night. At the direction of the Commission we proceeded to obtain proposals for the replacement of the 13 light poles equipped with LED lamp fixtures. As part of our seeking proposals for the replacement we focused on light fixtures that cast the lighting directly down. Our seeking of such a light fixture is part of our commitment to the dark skies program. In proposal seeking efforts we contacted FPL, Florida Bulb and Ballast, Boys Electric and Eau Gallie Electric. FPL offers a lease program plus cost of construction for installation. We attached it for review but the Commission had indicated earlier that it may not be cost effective. Florida Bulb and Ballast, Boys Electric and Eau Gallie all visited the installation site with the Public Works Director. FPL, Florida bulb and Ballast and Eau Gallie Electric have submitted proposals. FPL has only provided lease prices but not a construction cost. To date Boys Electric has not submitted a proposal. Director Davis has maintained email correspondence with them and they reported that they are working on it. Director Davis reviewed the proposals provided and reviewing the specs as to wind load requirements, warranties and amount of power used and lumens provided by the light fixtures they appear to be comparable equipment. After having exercised due diligence it the opinion of Director Davis that Eau Gallie Electric has offered the best proposal and request approval of the Commission to award that company the contract. It should be noted that once the contract is awarded it will take 6 to 10 weeks +/- for the materials to arrive.

Bids received:

- FPL: Lease \$78,360 (10 years) plus construction cost TBD
- Eau Gallie: \$31,903
- Florida Bulb & Ballast: \$53,810
- Boyds Electric: Inspected site but has not submitted bid after several requests

#### Recommended Action: Accept bid from Eau Gallie Electric
