Subject: Pine Street Traffic

Background Information: Chief Griswold sent me a memo regarding the high volume of traffic, pedestrians, bikers, and children on Pine Street in the morning and afternoon.

The Police Department counted the number of vehicles and their rate of speed at Sixth and Pine and used foot patrols to issue citations. Based on their findings the Chief would like to recommend the following:

- Placing a 3' fog line on both sides of Pine Street providing a guide for walkers and bikers.
- Reduce the speed limit from 25mph to 20mph from Andrews/Pine to south of Ocean Ave.
- Install Stop signs at First and Fifth Avenues.

Recommendation: Approved recommendations from Chief Griswold
