



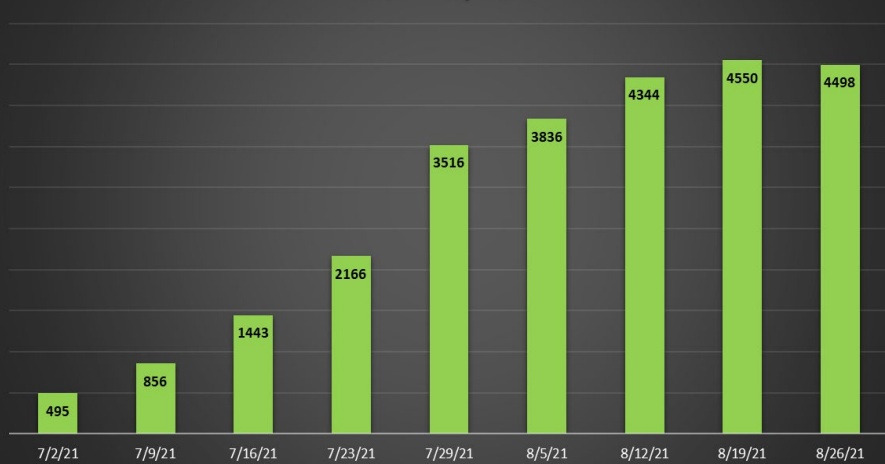

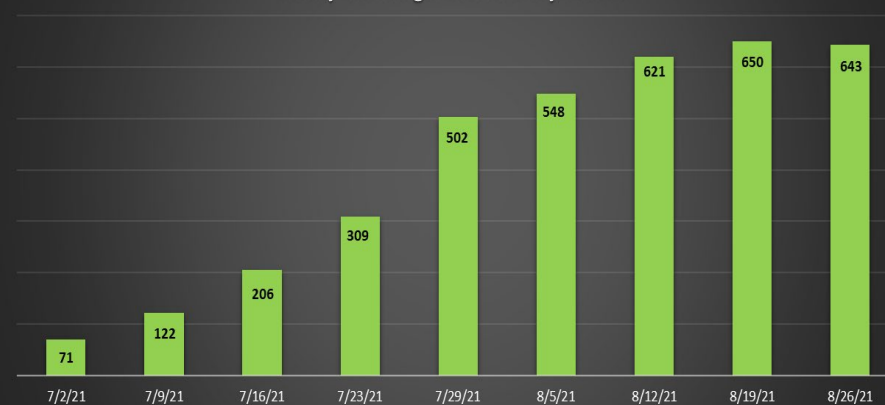

COVID Key Points

- Since the July 2nd a total of **25,704** COVID-19 cases have been reported in Brevard County
- DOH has partnered with Nomi Health, to provide COVID-19 PCR and rapid antigen test by appointment only
 - Hours of operation:
 - Monday to Friday 12 pm - 5 pm

 - Location:
 - DOH- Viera 2555 Judge Fran Jamieson Way
- Per DOH 64% of eligible Brevard County residents have received at least one vaccine dose
 - 38% of those between 12 - 14 years of age
 - 45% of those between 15 - 19 years of age

- Vaccines are available for individuals that are homebound due to health or mobility issues.

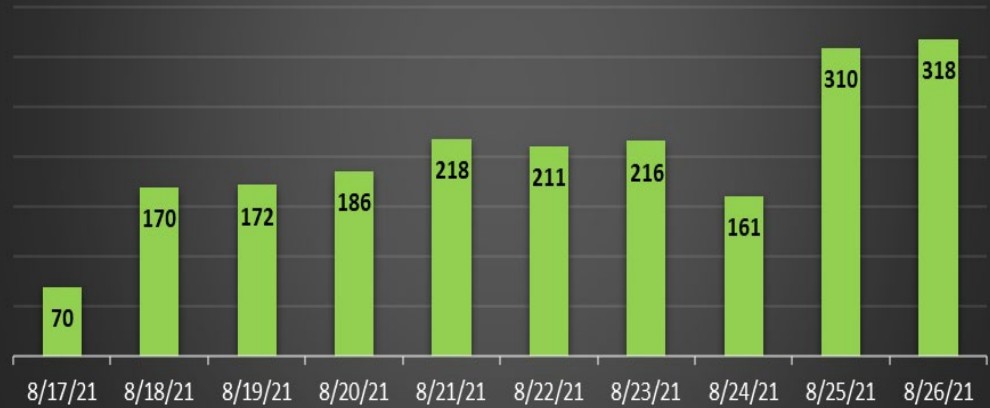

Brevard County Monoclonal Antibody (mAb) COVID Treatment Site

- The mAb treatment site at Kiwanis Island Park in Merritt Island, have administered **2,032** treatments since August 17, 2021
 - The goal of the treatment is keep COVID positive individual's symptoms at the medium to mild level therefore reducing the number of people who require hospitalization
- Eligibility for treatment:
 - 12 years of age and older
 - Individuals who are COVID positive or are experiencing COVID symptoms or have been exposed to someone who is COVID positive and are at risk for severe illness due to COVID 19
 - No referrals or doctor's notes necessary
 - Vaccination status does not matter
- Schedule appointments www.patientportalfl.com
 - Appointments are preferred
 - Walk-ups are being accepted at this time
- Treatment is free
 - Individuals will be asked for their insurance but it is not required to receive treatment
- How to Prepare for Treatment
 - Eat a small meal and drink plenty of fluids
 - Bring a book, tablet, or music
 - Have your ID and insurance card ready
- You will be on site for at least 2 hours so please be patient

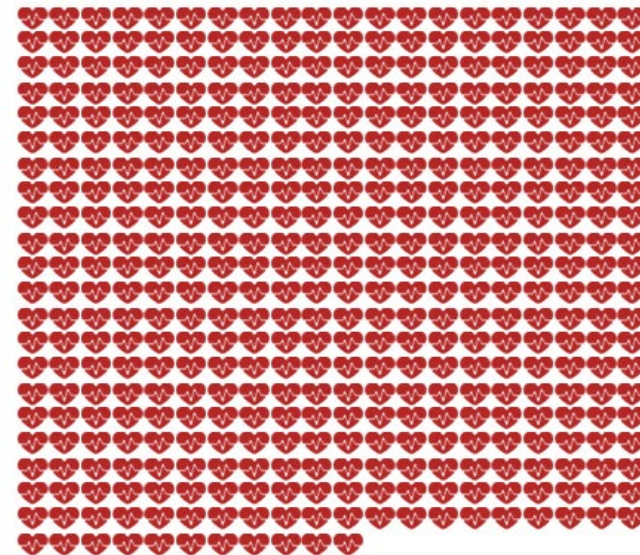
