Fire Department

FIRE TRAINING - Over the past few months, the Fire Department has conducted multiple training events at various donated structures here in the community. Here in Town, property owners can temporarily "donate" their existing structure to be used by the Fire Department for training purposes before the structure is demolished, allowing for realistic firefighter training exercises. Huge thanks to the Building Department and all of the recent property owners (Carlow family, Formica family, Brunosson family, and Hoelzel family) for allowing us the great training opportunities!



WATER RESCUES - The Department responded to multiple water rescue / drowning incidents at local area beaches during the months of February & March. Many of the incidents involved stronger than normal rip currents, and beachgoers inexperienced with ocean swimming. All residents and visitors should take the time to educate themselves on local conditions and rip currents before entering the water, and it is stressed that all ocean swimming should be done near a lifeguarded beach whenever possible. Scan the QR codes for a few quick resources on rip current awareness & safety:



IF CAUGHT IN A RIP CURRENT

- Relax, rip currents don't pull you under.
- Don't swim against the current.
- ♦ Swim out of the current, then to shore.
- ♦ If you can't escape, float or tread water.
- ♦ If you need help, yell or wave for assistance.
 - **SAFETY**
- Know how to swim.
- ♦ If in doubt, don't go out. Swim near a lifeguard.
- Never swim alone.

TALLAHASSEE, Fla.—Attorney General Ashley Moody presented a Florida Cabinet resolution recognizing March as Women's History Month to the Florida Police Chiefs Association highlighting the record number of female police chiefs in the state. Attorney General Moody is also encouraging other women to join the law enforcement ranks and help keep Floridians safe. According to the Florida Department of Law Enforcement, there are a record 7,410 sworn female officers in the state, currently making up 16% of all full-time officers in Florida—four points higher than the national average.

Attorney General Ashley Moody said, "Women's History Month is a time to recognize the incredible accomplishments of so many trailblazing women in

Florida, especially our female law enforcement officers. We are proud to have a record number of women police chiefs in our state, and a higher-than-average number of female officers. I'm glad to present this cabinet resolution to the Florida Police Chiefs Association and encourage other women to consider joining our law enforcement ranks by visiting BeAFloridaHero.com." According to FDLE, a record 20 police chiefs in the state are female. At least half of this group are the first woman police chief ever in their department's history.

Summertime Brings Extra Patrols

As a reminder, turtle nesting season begins May 1st. To prevent turtle hatchlings from being disoriented or trapped, lights out after 9 pm and fill in any holes on the beach.

Did you Know...


When a crossing guard or officer is stationed in the middle of an intersection ALL traffic MUST stop and remain stopped until the crossing guard or officer has cleared the intersection.

Visibility Triangle Requirements



All corner lots in the Town of Melbourne Beach received a letter in regards to the Visibility Triangle Requirements. The purpose of that letter was to make sure our residents are aware of and understand what the Visibility Triangle Requirements are. The requirements are important for the safety of the town residents, visitors, and the children traveling to and from school.

If anyone receiving the letter would like to have a site visit done to help explain what it is or see if they're in compliance they can contact the Building Department to set up an Inspection to help understand what the ordinance says.

Ordinance 2023-01 Landscaping and Trees & Fences and Walls

- Amends Section 9A-4 to require permitting, removal standards, and exempt trees posing an unacceptable risk in accordance with Florida Law.
- Amends Section 9A-5 regarding the number of tree removal plans required.
- Amends Section 9A-6 to provide for dimensions for replacement trees and justification for removal permits.
- Amends Section 9A-7 to revise minimum tree plantings for new construction and to add maintenance and replacement requirements.
- Amends Section 9A-10 to provide for clarified exemptions in accordance with State Law.
- Amends Section 9A-12 to provide for enhanced penalties for mature tree removal without a permit.
- Amends Section 7A-53 to allow for fences/walls extending beyond the front building line on residential lots abutting A1A and Oak Street south of Ocean Avenue to be erected to a maximum height of six (6) feet with required plantings and corner lot limitations.
- Amends Section 7A-53 to clarify references to fences and walls.
- Amends Section 7A-53 to add entrance gate standards.
- Amends Section 7A-58 to clarify references to fences and walls.

Ordinance 2023-02 Second Kitchens

- Amends Section 1A-3 to add a definition for "Kitchen" or "Kitchen Facility" which excludes outdoor barbeque areas without a range or stove
- Amends Section 7A-31 to cite to appropriate supplementary regulations.
- Amends Section 7A-32 to cite to appropriate supplementary regulations.
- Amends Section 7A-33 to cite to appropriate supplementary regulations.
- Creates Section 7A-72 to allow for second kitchens in 1-RS, 2-RS, and 3-RS zoning districts with permitting and regulatory conditions.

What is going on at the intersection of Cherry Street and Rosewood Drive?

A stormwater pipe has failed beneath the roadway causing the pavement to sink at that location. We had to take actions to replace the collapsed pipe or the road pavement would eventually cave in. With our rain season approaching we felt this project reached an emergency level. The Town Commission was presented with our dilemma and approved the spending of funds to make the necessary repairs. Work has begun and should be completed by the end of April.



Only Rain Down the Drain

PLEASE do not pile leaves, yard debris, or any material onto the streets. Everything placed there ends up in our stormwater drains and eventually into our Lagoon. Leaves from oak streets clog our filter boxes very quickly and limit the flow of water. Slowing the water flow results in street flooding. Public Works does a periodic check of our stormwater inlets and removes debris that has collected on and around them. Any action you can take to keep our stormwater inlets and curbs free of debris would be greatly appreciated.



Town Commission Meeting Highlights

January 4, 2023 - Special Town Commission Meeting

- Approved current Vice Mayor Joyce Barton to continue as the Vice Mayor and the Voting Delegate for the Space Coast League of Cities.
- Approved Commissioner Corey Runte as the alternate Voting Delegate for the Space Coast League of Cities.
- Approved the Bowman Consulting agreement for professional services in the lump sum amount of \$10,525.00 with the
 conditions of correcting the typo of Ocean Ave should be Riverside and addressing the note at the bottom which conflicts
 with the scope of work above which mentions adding landscape medians so the contract should include landscape, space
 planning, and basic design services.
- Approved the legal representation of Jim Simmons regarding the current lawsuit by Ms. Dennington.
- Approved proceeding with the removal of the existing gate opening system and replacing it with the proposal from Automatic Access Systems in the amount of \$9,795.00.

January 18, 2023 - Regular Town Commission Meeting

- Approved the \$7,000.00 increase in service fee adjustments for James Moore for Fiscal Year 2023.
- Approved Brewer Paving for the reconstruction of the underground pipe at Cherry and Rosewood in the amount of \$141,825.00.
- Approved the updates to Chapter 1 Procurement Procedure 1.03 Town Check Disbursements to reflect the bank services agreement.
- Approved the updates to Chapter 16 Town of Melbourne Beach Meal Reimbursement Allowances to reflect the current U.S. General Services Administration pricing guide for the destination.
- Approved the proposal by JustFoia in the amount of \$6,187.50.
- Denied the request to plant mangroves at the three river access points Avenue A, Avenue B, and Sunset as presented.

February 15, 2023 - Regular Town Commission Meeting

- Held a public hearing and passed the first reading of proposed Ordinance 2023-01, which amended Code Section 9A and 7A related to Landscaping and Trees.
- Held a public hearing and passed the first reading of proposed Ordinance 2023-02, which amended Code Section 1A and 7A related to Second Kitchens.
- Approved proceeding with changing the volunteer term lengths for the Environmental Advisory Board, History Center Board, Historical Preservation and Awareness Board, and Parks Board to three-year terms.
- Approved proceeding with changing the number of board members for the Environmental Advisory Board, History Center Board, Historical Preservation and Awareness Board, and Parks Board to seven members plus two alternate.
- Approved changing the meeting date for the History Center Board to the first Wednesday of each month at 5:00 pm.
- Approved moving forward with restoring the dolphin tree not to exceed \$4,000.00.

March 15, 2023 - Regular Town Commission Meeting

- Held a public hearing and passed the second reading of proposed Ordinance 2023-01, which amended Code Section 9A and 7A related to Landscaping and Trees.
- Held a public hearing and passes the second reading of proposed Ordinance 2023-01, which amended Code Section 1A and 7A related to Second Kitchens.
- Presented a proclamation recognizing January 2023 as National Human Trafficking Awareness and Prevention Month.
- Presented a proclamation recognizing April 2023 as Water Conservation Month.
- Approved a special event permit application.
- Denied the request to install a Clean-Up Station at Ocean Park.
- Approved the new contract for Computer Experts.
- Approved a request for reduction of code enforcement fine for case CEB 2019-CE-054.
