Melbourne Beach Police Department



In the month of July, we had a total of 3 criminal charges. 2 Misdemeanors and 1 Felony that range from traffic, warrants, grand theft, criminal mischief, and dealing in stolen property arrests. House checks/ residential and business checks are continued on a daily basis. One unattended death that was turned over to the Brevard County Sheriffs Department for investigation.

The officers and I continue to be proactive as they conducted 61 traffic enforcement details throughout the town, and we respond to residential complaints and have issued 16 traffic citations and ten parking citations.

Animal complaints, we had six calls this month. They range from loose, lost or found dogs, two dead cats from a possible fox and unknown group of people using flashlights on the beach looking for turtles.

Our areas of high volume calls consist of Injured/ILL persons. These calls are unpredictable, but each of our officers is First Responders/CPR/AED certified and are first on the scene to provide medical treatment as necessary.

All reports and calls for service are checked each day by either myself or a supervisor. Depending on the type of crime we have, procedures are in place to take the appropriate action to resolve the issue.

Our SRO Alex Vila has received 40 hours of training through the Brevard County Sheriffs Department's Tactical Rifle course. 5th and 6th graders received a presentation from SRO Vila on Anti-Bullying and options to prevent future incidents.

SRO Vila and Corporal Hinchman received their certificates from FDOT on proper helmet fitting. By earning their certificates, this gave us the opportunity to receive free helmets from FDOT to be given out to those students who are in need.

The Melbourne Beach Police Officers and I are committed to community policing and keeping our town safe which is our #1 priority.
