February 2019



In the month of February, we had a total of 6 criminal charges. 2 Felony and 4 Misdemeanors that ranged from Grand Theft and Battery Domestic Violence.

House checks/ residential and business checks are continued on a daily basis. The officers and I continue to be proactive as they conducted several "directed traffic enforcement details" throughout the town.

We had 5 animal complaints this month consisting of a loose dog, dog on the beach and a curious alligator at 6th Avenue River access.

Our areas of high volume calls consist of Injured/ILL persons. These calls are unpredictable, and each of the officers is First Responder/CPR/AED certified and is first on the scene to provide medical treatment as necessary.

All reports and calls for service are checked each day by either myself or a supervisor. Depending on the type of crime we have, procedures are in place to take the appropriate action to resolve the issue.

Our first "Coffee with a Cop" at Oceanside Pizza and "Meet and Greet" at the Community Center were successful, and we look forward to doing it again soon. Our SRO Alex Vila continues to promote positive reinforcement to students, parents, and teachers when needed at Gemini Elementary.

I have implemented the return of Officer of the Quarter, and SRO Alex Vila has been chosen by the department this first quarter. He will <u>be recognized</u> during the March 20th commission meeting. Congratulations!

The Melbourne Beach Police Officers and I are committed to community policing and keeping our town safe which is our #1 priority.

MONTHLY REPORT FOR (FEB 2019)

02/05 – Battery in the 400 block of Colony St. Cable company representative kissed a customer while work was being completed at the residence. Capias sent to State Attorney's Office.

02/13 – Baker Act in the 500 block of Sunset Blvd. Intoxicated female with scratches and cuts all over her body. The female was nude and banging on neighbor's door across the street. Female was evaluated and transported to Holmes for injuries and then turned over to Circles of Care.

02/15 – Traffic Crash at 300 Ocean Ave. Vehicle 1 was a delivery truck in the back lot of the above address and struck a parked vehicle while trying to go around the corner of the building. No injuries reported and long form completed.

02/15 – Verbal Domestic in the 1700 block of Orange St. Mother and daughter constantly arguing over the daughter's lifestyle and the parents always stating they want the daughter to move out. Officers continue to give her civil information to have her evicted.

02/20 – Traffic Crash at Ocean Park. V1 backing up struck V2 who was parked. No injuries were reported and there was minor damage. A short form was completed for both parties.

02/21 – Baker Act in the 300 block of Third Ave. Female ran from house into backyard when we arrived. Complainant stated she was yelling and throwing items in the bedroom. When trying to question her, she stated "just kill me, I want to die!" She was transported to Circles of Care for treatment.

02/21 – Traffic Crash at the intersection of Oak St and First Ave. V1 was trying to pull out of First Ave onto Oak St where traffic was stopped for the red light. V1 failed to yield for a vehicle in the other lane of Oak St where traffic was still moving. V1 collided with V2 which made V1 also collide with another vehicle in traffic. No injuries were reported and the driver of V1 was cited for failure to yield.

02/28 – Domestic Violence Arrest – 300 block of Ave B. Husband pushed wife then left with her purse that contained her cell phone. Wife hid in closet and started emailing friends to have them call the police. Husband responded back to the residence and was subsequently arrested for Battery Domestic Violence.

MONTHLY REPORT FOR (February 2019)

- 02/08- Arrested male for battery, domestic violence, in the 400 block of Sunset Boulevard. The male ripped a necklace off of his girlfriend, whom he lives with, causing her to fall back against a table.
- 02/17- Vehicle crash between two vehicles at Oak Street and Acacia Boulevard. No injuries were reported and there was only minor damage to both vehicles.
- 02/17- Battery in the 400 block of Avenue B. Two males got into a physical fight and were broken up before officers arrived. There were only minor injuries to one male and both parties signed a Decline to Prosecute.
- 02/18- Domestic, verbal dispute, between boyfriend and girlfriend in the 300 block of Third Avenue. Parties were separated for the night.
- 02/24- Death Investigation in the 200 block of Fir Avenue. Officers responded to an unresponsive 37 year old male and attempted CPR. The male was transported to Holmes Regional Medical Center, where he was pronounced deceased. The Brevard County Sheriff's Department is handling the investigation.
- 02/25- Baker Act of a male in the 300 block of Surf Road.
- 02/27- Domestic, verbal dispute, between boyfriend and girlfriend in the 300 block of Third Avenue. Parties were separated for the night.
