MONTHLY REPORT September 2018

In the month of August, we had a total of 9 criminal charges. 6 Misdemeanors and 3 Felony that range from Traffic, Domestic Violence, Disorderly Intox, Resisting an Officer without Violence, and Drug arrests. House checks/ residential and business checks are continued on a daily basis. One unattended death that was turned over to the Brevard County Sheriffs Department for investigation and was determined to be of natural causes.

The officers and I continue to be proactive as they conducted 50 traffic enforcement details throughout the town, and we responded to residential complaints and had issued 13 traffic citations and seven parking citations.

Animal complaints, we had two calls this month. They were a loose dog returned to the owner and a dog on the beach.

Our areas of high volume calls consist of Injured/ILL persons. These calls are unpredictable, and each of the officers is First Responder/CPR/AED certified and is first on the scene to provide medical treatment as necessary.

All reports and calls for service are checked each day by either myself or a supervisor. Depending on the type of crime we have, procedures are in place to take the appropriate action to resolve the issue.

Our SRO Alex Vila met with students and parents during there open house and did a presentation on anti-bullying. He is also making the final preparations for National Walk to School Day which will happen on October 10th.

On September 24th at 2100 Oak Street, our 2012 Caprice patrol vehicle # 365 was struck by a Brevard County Sheriffs Deputy patrol vehicle while he was having a medical issue. There were no injuries as a result of the crash, and the deputy was later released from the hospital in good condition. Sheriff Ivey provided our agency with a marked loaner vehicle from his fleet until we receive our already budgeted patrol vehicle.

The Melbourne Beach Police Officers and I are committed to community policing and keeping our town safe which is our #1 priority.

MONTHLY REPORT FOR (SEPT 2018)

09/09 – Attempted Burglary to a Vehicle in the 200 block of Fourth Ave. Suspect checked doors but vehicle was locked, suspect was identified by officers from victims camera. Suspect's PO was called and will violate his probation.

09/13 – Traffic Crash at Sand on the Beach. Minor damage to both vehicles. Vehicle backed into a parked vehicle. Driver's Exchange completed.

09/14 – Traffic Crash at Oak St and Ave A. Vehicle 1 crossed over Oak St heading east on Ave A and did not yield to Vehicle 2 who was heading north on Oak St. Vehicle 2 was struck in rear, spun out and collided with Vehicle 3 that was facing west on Ave A at Oak St waiting for traffic. All vehicles had substantial damage and 2 victims were transported to the hospital with minor injuries.

09/21 – Unattended Death in the 300 block of Ave A. Possibly suspicious, turned over to agent from BCSO.

09/21 – Baker Act in the 2100 block of Oak St. Female juvenile transported to Circles of Care for treatment.

09/24 – Traffic Crash at 2100 Oak St (Gemini Elementary). Deputy from BCSO in his patrol unit had a medical episode. Vehicle struck multiple street signs and the front end of a MBPD vehicle that was unoccupied park on the side of the road for school zone. No injuries reported.

MONTHLY REPORT FOR (September 2018)

09/02- Vehicle crash between two vehicles in the 300 block of Ocean Avenue. No injuries were reported, one vehicle had minor damage and the other had major damage, needing to be towed.

09/10- Baker Act of a juvenile female in the 2100 block of Oak Street

09/17- Arrested a male for Battery, Domestic Violence, in the 600 block of Jasmine Drive. Father and adult son were arguing, when the father grabbed the son by his shoulders.

09/20- Grand theft of money from the 900 block of Oak Street. An unknown suspect cut a lock from an Air Vending machine and stole an undetermined amount of change.

09/20- Baker Act of an elderly adult male in the 400 block of Fifth Avenue.

09/26- Vehicle crash between two vehicles at Oak Street and Avenue B. No injuries were reported and only minor damage to both vehicles.

09/27- Arrested a male for Disorderly Intoxication and Resisting Arrest without violence, in the 900 block of Oak Street. An officer attempted to make contact with a suspicious intoxicated male and while doing so the male refused lawful orders and resisted arrest.

09/27- Arrested a male for possession of under 20 grams of marijuana and possession of drug paraphernalia, in the 2100 block of Oak Street. The Male was stopped for speeding and after a search of the vehicle based on the smell of marijuana; the items were located inside the vehicle.

09/28- Indecent exposure at the Fourth Avenue beach access. An unknown male exposed his penis to a mother and adult daughter on the beach. A photo was taken of the vehicle the male was driving and that, with a description of the male, was given to the surrounding agencies.
