

# **Crime Prevention for Parents**

Melbourne Beach is regarded as one of the safest cities in Florida, but that's no reason for parents to let their guard down. Although, Melbourne Beach Police Department will always respond to crime, the police can't do it alone. Get informed, get involved and make crime prevention a part of your everyday life. Chief Duncan provided a few safety tips. The safety tips are a good start for creating awareness and building selfconfidence your child may need to handle an emergency.

- Make sure your children know their full name, age, address and telephone number with area code. Always have them carry identification in their pocket (not visible).
- Be sure they know how to contact you in an emergency, as well as how and when to call 9-1-1 to reach emergency services.
- Always locks doors and windows and see who's there before opening the door.

Chief Duncan reminds you to be alert for changes in your child's behavior that could signal abuse, such as sudden secretiveness, withdrawal from activities, unexplained cash or expensive items, refusal to go to school or a favorite activity, increased anxiety or unexplained hostility toward a particular person or place. Always remember - if your child is a victim of any crime, from stolen lunch money to sexual abuse, don't blame him or her. Listen, offer sympathy and report it to the proper authority. Be safe!

# Hey! A Mosquito Bit Me!

Is something deadly breeding in your yard?

Recently the number of complaints in Melbourne Beach about mosquitos has grown. In response, the Town Mayor, Jim Simmons, contacted mosquito control to find out what was causing this big problem in our small town. The results of the site visit were surprising. The town learned that although spraying helps it cannot solve the problem. It was confirmed that our mosquito problem is primarily due to container grown mosquitos.

What is a container grown mosquito? Container grown mosquitoes are mosquitos that are produced in any type of item or container that holds standing water. Some of those you may have around your home are potted plants with pans, clogged roof gutters, water build-up due to your water faucet or air conditioning drain, large animal troughs, old tires, unused pools, bird baths, barbecue grills, ash trays, or other small container.

What Can I do to help? Some ideas for ensuring your are not breeding mosquitos are to not overwater plants or remove the water pans under the plants, clean your rain gutters, replace the water in your pets dish every few days, cover rain water catches with screen to prevent mosquito larvae, empty pools or flush weekly, cover your grills, over turn or remove containers or flush at least once a week.

We hope we can count on you to do your part to reduce this BIG small-town problem.
