A. Town Manager Applicant Interviews

Mayor Simmons explained our interview process. The interview is one hour long. At 4:30 p.m, the interview with Bill Cannon commenced. Mr. Cannon gave an almost 10 minute opening statement. The Commission began asking their questions starting with Mayor Simmons. B. Discussion regarding Town Manager Applicants


There was no discussion.

VI. Adjournment


Commissioner Hoover made a motion to adjourn; Commissioner Walters seconded. Motion carried 5-0.
